### Application

<b>Processing conditions :</b>	apply from + 5 °C temperature of the object or the environment and up to 80 % relative air humidity.
<b>Application process :</b>	<b>brushing</b> a test coat on the object is recommended. A sticky film will be obtained when applied in too thick coats. Excess paint on the surface after treatment should be removed with a clean cloth.
<b>Thinner :</b>	Mipa Terpentinersatz (turpentine substitute)
<b>Drying times : (15 - 20 °C)</b>	up to 24 hours. Prolonged drying time after treatment due to high humidity conditions, lower temperature or different thinner (turpentine) concentrations.
<b>Consumption:</b>	approx. 15 m <sup>2</sup> /l
