### Application

<b>Processing conditions:</b>	Do not apply at substrate and ambient temperatures below +5 °C and above +35 °C or in direct sunlight or strong wind.
<b>Substrate preparation:</b>	<p>Carefully remove moss. Do not remove or touch mould before spraying! Dispersing spores may lead to infections and contaminations.</p> <p>Bleaching effect may cause changes in colour shade of textiles, wallpapers, carpets, elastic sealing compounds; if necessary, test on an inconspicuous sample surface. Do not spray on raw metal parts. Wash off sensitive surfaces immediately.</p>

**Application:**

Use sparingly. Spray from a short distance (5 - 10 cm). The immediately visible colour change indicates the fast effect. Repeat spraying to remove still visible stains. No scratching or scrubbing, do not wash off. The treated surface remains sterile for a long time and thus reduces new infestation. Attention: Only wash off permanently elastic joints and tile joints after 10 minutes.

**Spreading rate:**

approx. 100 ml/m<sup>2</sup>. The spreading rate depends significantly on the absorptivity of the substrate and on the intensity of the infestation.

**Safety instructions/ First aid**

**Use biocide products carefully. Before use, read the product label as well as the technical data sheet.**

After each use: Rinse the sprayer with clean water. Close the original container again. Take care of your clothes when using the spray!
